Shareholder notification: influence of Sertorius Global Opportunities Fund exceeding 5%

In accordance with Section 61 of Act CXX of 2001 on Capital Markets („Capital Market Act”) on basis of the attached shareholder notification Egis Pharmaceuticals PLC announces that the influence of Sertorius Global Opportunities Fund Pte Ltd managed by CSAM Asset Management Pte Ltd (80 South Bridge Road Golden Castle Building #03-01, Singapore 058710) has reached and exceeds 5% level specified in the Capital Market Act, now holding 404,223 Egis shares after the change, representing 5.192% of total votes.
